Scholarship Application

Eligibility:

1. Applicants must be a member in good standing of the Conservation Employees' Credit Union
2. Applicants must plan to attend a college, university, or other post-secondary educational institution within the U.S. on a full-time basis during the next academic year.
3. 2024 CECU scholarships are a one-time award of \$1,250.
4. Members may reapply each year, but cannot receive more than two scholarships over their lifetime.

Procedure:

1. The following information must be submitted on the designated forms:
 - **Completed application.** Please answer all questions fully. Failure to provide all requested information may result in rejection of the application.
 - **Transcript.** This must be an official High School or College transcript/grades issued by your school. If a home-school student, a letter clarifying your home-school status must accompany the transcript.
 - **An essay introducing yourself and stating your educational goals.** The essay must be typed using a font size of either 10 or 12, and is not to exceed one sided double-spaced page. Essays which do not conform to these specifications will be rejected.
2. Mail completed application and related documents to the address at the top of this page. Transcripts may need to be mailed separately from your school; however all required materials must be received in the Credit Union no later than **midnight March 15th** to be considered.
3. Scholarship funds will be disbursed directly to the member or the member's account once the credit union receives a letter from the school for verification of enrollment for the Fall term.

Application components are weighted as follows:

- Essay = twenty percent (20%)
- GPA/Academic Status = twenty-five percent (25%)
- Extracurricular School/Community Involvement and Service; and Employment Record = thirty-five percent (30%)
- Personal Accomplishments, recognitions, and awards = twenty-five percent (25%)
