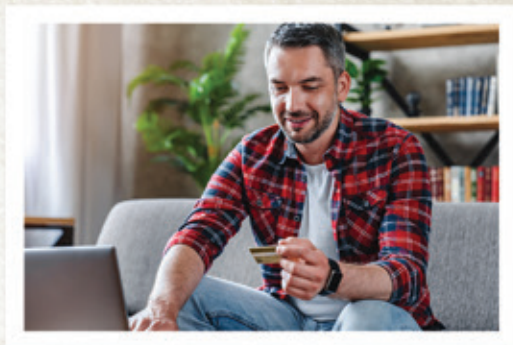

# Celebrate Missouri's Bicentennial with an MCHF Donation



In honor of Missouri's bicentennial – its 200th birthday – the Missouri Conservation Heritage Foundation (MCHF) wants to **reflect on our rich history and decisions made in the past** that have had such a profound influence on who we are today as Missourians. Conservation is a major part of our rich American history. **Since 1937, conservation leadership began the journey of preserving our great state's natural resources for all citizens to enjoy the outdoors.** We have been at the forefront ever since, and ours is the model other states emulate. **We urgently need your support to continue to be the best!**



Since the inception of MCHF in 1997, we have played a small role with you in supporting Missouri's conservation legacy, **providing more than \$24 million in support to programs.** Let us give you some examples of how **you – the donor – have made a difference.** Learn more in our annual report found at [mochf.org/annual-report](https://mochf.org/annual-report).

- **Stream Stewardship Trust Fund:** MCHF supports stream mitigation projects, and Missouri has the oldest mitigation program in the country, spending more than \$6.1 million to preserve the state's streams and riparian corridors.
- **Migratory Birds:** MCHF has partnered with multiple donors to support the MOTUS Wildlife Tracking System, which tracks migratory birds from Central America to North America. The Missouri Department of Conservation has placed tracking receivers in strategic areas across the state.
- **National Lewis and Clark Conservation Awards:** This national award program exemplifies the best in Missouri conservation by recognizing leaders and organizations who have made significant contributions.
- **Missouri National Archery in the Schools Program (MoNASP):** Missouri has grown over the past three years to become the second-largest archery program in the country. Every year, students across the state in grades 4-12 compete to become eligible for

the state tournament held in Branson. MCHF, in partnership with the Missouri Department of Conservation, continues to grow this significant program for youth.

- **Endangered Species:** MCHF supports programs for endangered species and species of concern throughout the state.
- **Hunting and Fishing Programs:** MCHF sponsors a myriad of programs and camps to get youth outdoors and comfortable with various activities. MCHF has invested in handicap overlooks, docks for fishing and track chairs to help disabled hunters and veterans get into the field to enjoy nature, fish and hunt.
- **Land Bank:** Partnering with Burns & McDonnell Engineering, MCHF opened the Chariton Hills Conservation Bank, the first in Missouri approved by the U.S. Fish and Wildlife Service.
- **Urban Programs:** MCHF supports programs in Kansas City and St. Louis, and most recently has worked with the Green City

Coalition in St. Louis in reclaiming abandoned property and supporting green programs in an urban setting.

The Missouri Conservation Heritage Foundation will weather this storm and grow to be stronger in its mission of supporting conservation across our state. **And with your gift, you will help secure the future of conservation.**

# Fight Back Against Fraud

Scammers keep getting more creative and convincing, so it's important to stay one step ahead of them. According to the Federal Trade Commission (FTC), there are multiple ways to spot fraudulent activity:

- 1. The email, text or phone call appears to come from an organization you know**, such as the Internal Revenue Service (IRS) or Social Security Administration (SSA), but doesn't seem quite right. These communications will look and sound very official – and yet they're *absolutely* not! Government agencies **always** send official notices through U.S. mail **only**.
- 2. The con artist announces an urgent problem or opportunity that must be addressed immediately**, usually by clicking on a link (in a text, email or social media message) or in response to a call. They often use scare tactics like threatening to arrest you or seize your assets. They might claim that your accounts have been frozen or that a loved one has been kidnapped – they'll try just about anything to get you to act.
- 3. The fraudster demands payment in a specific way**, including purchasing gift cards, cashing a check on his or her behalf (which ends up bouncing) or sending money through a money transfer company. Other times, they'll claim that you won a prize, but you must pay fees to collect it.

Sadly, the pandemic provided an opportunity for new imposter schemes related to stimulus checks (from the CARES Act), medical "cures" and fake COVID-19 testing sites. Be wary if the Food and Drug Administration (FDA), Centers for Disease Control (CDC) or World Health Organization (WHO) contact you by email, text or phone. Don't share your financial and health insurance information unless you were the one who initiated the call.
